GEAC Accreditation

(National & International Standards for Accredited Institutions)

- * GEAC ACCREDITED INSTITUTIONS SHOULD HOLD A STATE CERTIFICATE OR LETTER OF EXEMPT AUTHORIZATION AS A POSTSECONDARY INSTITUTION TO OFFER CREDENTIALLED CERTIFICATE OR DEGREE.
- * GEAC ACCREDITED INSTITUTIONS SHOULD HAVE ACADEMIC WEBSITE AND FACEBOOK PAGE.
- * GEAC ACCREDITED INSTITUTIONS SHOULD PROMOTE ACADEMIC INTEGRITY. DEGREES AND COURSES OFFERED BY INSTITUTION SHOULD BE EARNED BY STUDENTS OR FACULTY.
- * GEAC ACCREDITED INSTITUTIONS REGISTRATION, TUITION AND FEE RATES SHOULD BE COMPATIBLE TO OTHER NON-FEDERAL FUNDED INSTITUTIONS.
- * GEAC ACCREDITED INSTITUTIONS ARE SOME OF THE MOST AFFORDABLE INSTITUTIONS AROUND. THEREFORE, GEAC ACCREDITED INSTITUTIONS SHOULD NOT UNDER BID THE ACADEMIC COMMUNITY. STUDENTS NEED TO PAY THE TUITION COST FOR EDUCATION AT EACH INSTITUTION, SET FORTH BY THE INSTITUTION.
- * GEAC ACCREDITED INSTITUTIONS NEED TO UNDERSTAND, CERTIFICATE AND DEGREES NOT PAID FOR AND WORK NOT COMPLETED BY STUDENT, MAKES ANY INSTITUTION A DIPLOMA MILL. (HONORARY DEGREES INCLUDED)
- * GEAC ACCREDITED INSTITUTIONS NEED TO PAY ANNUAL ACCREDITATION RENEWAL FEE AND COMPLETE ANY UPDATED COMPLIANCE INFORMATION IF REQUESTED. GEAC INSTITUTIONS THAT STAY IN COMPLIANCE WILL ATTEST, THAT IT IS OPERATING AT OR ABOVE MINIMUM STANDARDS SET FORTH BY THE U.S. AND STATE DEPARTMENT OF EDUCATION.
